A. General Terms and Conditions of Use

1. Definitions

- 1.1. In this user agreement, the terms below have the following meanings:
 - 1.1.1.  - 1.1.5. "you" and "your" means the user of the Site and / or your legal guardian.

2. Conditions of Access

- 2.1. Your access to, and use of, the Site is subject always to the terms and conditions set out in this user agreement.

- 13.3. No failure or delay by Order Logistics to exercise any of its rights will be regarded as a waiver of its rights, nor will it affect the validity of any part of this user agreement.

14. Term and Termination
